Amy Biehl High School is proud to host a dynamic speech tournament in the school's historic courtroom, bringing together talented students from across Albuquerque to compete in legal-focused categories. This event offers a unique opportunity for students to showcase their public speaking prowess, build confidence, and engage in spirited, constructive competition. Participants will be evaluated on their ability to craft and deliver clear, persuasive, and well-structured speeches, fostering both personal growth and a sense of community among the next generation of orators.

Teams of 2-3 students will be guided by a sponsoring attorney, focusing on law-related topics. Each team will collaborate to develop their speeches, gaining invaluable insights and mentorship from their coach. To further elevate the stakes, the winning team will be awarded a cash prize, adding an exciting incentive to perfect their arguments and deliver their strongest performance. The competition will follow a bracket-style format, with each team receiving a legal dilemma to address (e.g., Does the Executive Branch have the authority to conduct mass firings of federal employees?). One team will argue for the issue, while the other argues against it. After receiving their debate topic, teams will have 45 minutes to prepare, crafting a well-reasoned argument supported by cited facts. Speeches should last between 5 and 7 minutes. The winning team will advance to the next round, while the losing team will be eliminated from the competition.
